As requested in your letter of August 11 and in our telephone conversation, I am pleased to enclose copies of some of the affidavits filed in connection with the preliminary injunction motion brought by Pfizer in its suit against International Drug Trading Inc., Norman S. Cohen, et al. The report in the "Pink Sheet" erroneously indicated that all five defendants have been enjoined. Actually it has issued only against the two named defendants.

Also enclosed is our copy of the transcript of the deposition of Mr. Wineberg taken in this action. I believe it will be apparent from these papers that both International Drug Trading Inc. and Mr. Cohen are financially irresponsible. Please return the transcript copy after perusal.

I am advised that efforts to serve the preliminary injunction on the above named defendants have not yet been successful, because the offices of International Drug Trading Inc. at Room 1810 Washington Boulevard Building, 234 State Street, Detroit, were closed and Mr. Cohen could not be found. The latter seems to be down in Washington seeking financial backing for his proposed manufacturing operations.
