### Intellectual Property Systems

Promote innovation and creativity by recognizing the right of the inventor and creator to obtain legal

- protection and economic reward for his work, for a limited duration.
- Enrich society through creation of knowledge,
- technologies, music, art, literature and promoting cultural development.
  - Promote industrial activity by providing access to etechnology and investment and encouraging fair trade.










#### What does WIPO do?

WIPO plays a key role in evolving and developing international intellectual property laws through treaty egotiations and soft laws.

- WIPO through its global *registration* systems for patents, trademarks, and industrial designs provides
- services to industry and the public sector.
- WIPO provides assistance to developing countries currently in the process of building up their patent,
- trademark, and copyright laws and systems for economic and cultural development.
  - WIPO explores and studies intellectual property dimensions of global issues



#### The WIPO Patent Agenda

- New initiative launched by the Director General in September 2001, intended to launch worldwide discussions leading towar strategic blueprint for future evolution of the *international pat* system (IPS).
- Long term objective of IPS: available mechanisms and programallowing for effective national, regional and international pater protection systems which are simple, inexpensive, timely/reliable; and supports exploitation of patented technology.







#### **The Patent Cooperation Treaty**

- Objective: to simplify and facilitate the means of applying for patent protection for inventions in several countries in a cost-effective manner
- Entry into force: January 24, 1978
- Original membership: 15
- Current membership: 115 Contracting States
- PCT Reform Process




## MADRID System for Internationa Registration of Marks

- Gives trademark owner possibility to have his mark protected in several countries with one application in one language and one set of fees in one currency
- Objectives: to facilitate the obtaining of protection for marks; and to make easier the subsequent management of that protection



#### The HAGUE System for the International Deposit of Industrial Designs

 Objective: To allow the possibility of protection of industrial designs in several countries through a single deposit with the International Bureau of WIPO, in one language and with one set of fees in one currency





#### IGC on Genetic Resources, Traditional Knowledge and Folklore (1st and 2nd)

- Genetic Resources: development of guide on contractual practices and model IP clauses for contractual agreements on access to GR
- *Traditional knowledge*: discussions on sui generis system of protection; inventory of TK-related periodicals; TK as prior art; etc.
- Folklore: report on nat'l experiences with legal protection of expressions of folklore (ongoing)

Domain Name Process (07/1998-04/1999)


- Scope: Questions arising out of the interface between domain names and trademarks
- WIPO as uniform dispute resolution provider for gTLDs and ccTLDs since December 1999
- Cases filed up to end 2001: 3,348
- Cases completed up to end 2001: 3,070
- Second WIPO Domain Name Process (07/2000-09/2001)
  - Scope: personal names, Int'l Nonproprietary Names, names IGOs; geographical indications; trade names
  - Consultation process ongoing

## Electronic Commerce, Issues for Developing Countries

- Access and Participation in electronic commerce
- Opportunities
  - accelerated integration into global economy
- Challenges
  - necessity of up-front investment
  - relative lack of participation in policy-making and standard setting for e-commerce
  - absence of sufficient information infrastructure

#### WIPO's Response

- Identification of IP issues raised by e-commerce and assistance in formulation of appropriate policies
- Development of updated IP regime conducive to e- commerce
